Directors Call Notes – 2/18/2021

Post Cluster Planning – Last year, when New York State developed their Cluster Action Initiative to address covid hotspots in the state by assigning color-coded clusters with additional restrictions, 4CLS responded by developing a Cluster Action Plan. That plan called for certain measures to be taken should a cluster be declared within the 4cls region.

At some point late in 2020, New York State abandoned the cluster model without any notification. Numbers increased after the holidays and no clusters were declared. Since the basis for the 4CLS plan is no longer applicable, a different measure needed to be developed.

The 4CLS Steering Committee recommends that libraries monitor the new daily cases and the 14 day average for new cases by 100K population. These figures are helpfully compiled on a by-county basis by the New York Times. The committee further recommends that libraries pay particular attention to the trend line and respond to any sharp increase by with a careful examination of library operations. A more complete statement will be sent soon.

Construction – A lot of libraries have completed or are undertaking construction projects. Including:

- Oxford adding solar panels and a charging station for cars
- Oneonta making improvements to the park
- South New Berlin adding an addition

- Bovina Lifting the floor, renovating the basement, adding a lift
- Andes Major renovation
- Worcester Added air conditioning
- BCPL Painting and replacing old carpets with flooring
- Whitney Point Pulling up carpet and refinishing floors
- Richfield Springs Replacing historic windows
