Congratulations to Andes for going live with automation next week.

Going forward, we'll plan for a Directors Conference Call on the first Thursday of the month. The next one will be on Thursday, March 3 at 3:30 PM.

Presentation by Dr. Chris Ryan – Dr. Ryan joined the group to discuss Upper Room Germicidal Irradiation – a technique used to clean the air that has been in use for decades. See the attached slides for more information on the technology and basic pricing. The devices are eligible for construction aid. If there is sufficient interest, Steve will arrange for a meeting with a vendor.

State Budget – The Governor's budget is good and bad. She included an additional \$2 Million in basic aid for libraries (still below the statutory minimum), but she also cut \$20 Million from construction aid. 4CLS is arranging virtual meetings with our state legislators on or near NYLA's Advocacy Day on March 2.

ARPA Update – Our system's application for ARPA funding was approved. Steve will be in contact with libraries that signed up for computers to confirm before orders are placed. Libraries will be able to choose desktop or laptop computers. We cannot fund the entire request. Reminder—these computers must be for patron use.

Libraries are required by the minimum standards to compile an annual report to the community. There aren't a lot of rules about what the report looks like. It is customary to report basic financials (income & expenditures), measurable stats (circulation, programs, etc), and provide a narrative section to tie it all together. Libraries have presented reports in formats such as bookmarks, brochures, newsletter articles, infographics, etc.

A great time to build and send the annual report to the community is just after the completion of the state annual report. The data is already compiled.
